Billing:

Each session is booked and billed on an individual basis unless otherwise requested by the client. Session rates are due at the end of each session and are billed electronically to the client via Venmo or PayPal. *Established clients and clients with special financial circumstances (contact Mira directly to discuss) will be invoiced at the end of each session and are expected to pay the total amount due from the session within two weeks' time.

Cancellation Policy:

All cancellations and rescheduling requests for sessions are expected to be communicated with 24-hour notice. Cancellations or reschedules (especially habitual ones) that occur the same day will be billed the full session amount. Communications about emergency circumstances are understood and encouraged - if you have a personal emergency and need to cancel or reschedule that is appreciated unless it becomes a habitual circumstance (3 or more sessions being rescheduled or canceled on the same day over the course of the service relationship).

Insurance:

A this time Moon & Rune Wellness does not accept insurance or fulfill requests for proof of disability or diagnosis. Records or client note requests must be made by the existing client and are provided at no charge.
